Fishing Regulations & Dates 2017

Fishing season: May 10 – October 20

(For holders of annual fishing licences the season ends on October 31.)

1. Fishing is allowed only with valid annual fishing licence or fishing guest licence and permit. Persons, who have completed their 10th year of life but not yet their 14th, are allowed to fish only under survey of a person fully capable of acting. All licences are non-transferable.
The fishing guest card is valid from 00.00 on day of issue until 24.00 on the last day of the validity period!
2. It is compulsory:
 - a) To observe close seasons and size limits. Undersized fish have to be carefully taken off the fishing rod with wet hands and released into the water.
 - b) Not to release dead and evidently ill fish as well as dead lure fish.
 - c) To illuminate the fishing place in order to keep it constantly visible during night fishing as well as not to let unattended the laid-out fishing rods. When fishing with floats they have to be kept visible by illumination too.
 - d) To show fishing licence, equipment and caught fish to the fishing controlling bodies and to give the required information.
 - e) **If undersized fish are hurt badly when caught, so that their survival can't be expected, they have to be killed in accordance with the animal protection laws, fragmented and put into the water.**

3. It is prohibited:

- a) To catch more than 3 fish in total per day which comply with the size limits.
Except for pikes and perches.
- b) To catch **more than one trout** (>60cm) per day.
- c) To fish apparently stocked trouts.
- d) To fish with more than 2 fishing rods (with one lure each).
- e) To fish from a non muscle-powered watercraft (use of electric motors, combustion motors etc. is prohibited). **Incline electric motors!**
- f) To use explosives, narcotic substances, firearms, hooks, harpoons, loops and electric fishing gears.
- g) To hook, drag, bounce, cull, as well as the use of artificial or chemical lights to attract aquatic animals.
- h) To use living vertebrates as lure as well as self-brought lure fish.
- i) To use fish innards as lure.
- j) To possess and use echo sounders or other locating devices on any watercraft (canoe, raft ...) with fishing rods on board.
- k) To fish from the boat or other watercrafts (canoes, rafts...) from one hour after sunset until one hour before sunrise (night fishing).
Exceptional rule for the area west of Ronacherfelsen: Night fishing from footbridges and other artificial installations is allowed. It is prohibited to use unsecured structures (natural shores) as fishing places during night fishing!
Exceptional rule for the area east of landing stage "Kleine Steinwand": Fishing from a boat fixed on the shore is allowed in this area. The boat has to be illuminated and kept visible. The laid-out fishing rods have to be attended constantly. Floats have to be kept visible by illumination! It is not allowed to camp on the shores within the protected area.
- l) To fish in all feeders and outflows and in their confluence into the lake (15 m).
- m) To fish in cultivation areas of water and cow lilies (plant conservation).
- n) To pour more than 3 litres of feeding stuff/day (impact on water quality).
- o) To keep caught fish in artificial containers for more than 12 hours.

4. Please:

- a) Do not fish from the landing stages and the bridge (penalization according to traffic regulations).
- b) Do not mark fishing places by buoys or other features.
- c) Regard the safety of bathers (risk of injury).
- d) Immediately inform Weissensee Information or the police about particular notices of all kind.
- e) Leave your fishing place clean.

Non-observance of these regulations will result in suspension of the issued fishing licence and the list of catches.

THERE IS NO RIGHT TO A REFUND OF ALREADY PAID RATES AND THE DEPOSIT!

Please mind that the lesser above mentioned regulations are observed, the stricter future regulations and punishments have to be remitted. Please also consider those who will come after you, hoping to enjoy their hobby just like you.

Non-registration may result in suspension of the fishing licence.

The reissuing of the fishing licence can depend on this refund.

Non-observance of these regulations will result in suspension of the issued fishing licence and the list of catches.

There is no right to a refund of already paid rates and the deposit!
